# CP 103 Ethics for Mental Health and Addictions Counselors

Dr. Waterson Spring 2020

#### **Course Description:**

This course is designed to provide the student with an in-depth review of ethical and professional issues in the practice of mental health and substance abuse counseling. Students explore the nature of ethical decision-making in relation to the ethical codes of the ACA and AMHCA, legal requirements, and case examples from different modalities (adult, children, families, groups). The course examines issues of professional practice such as the counselor's role, working within systems, and managed care as well as understanding of licensure and regulatory practices. *This course is designed to meet the licensing board's requirement for a course on Professional Orientation*.

## **Learning Objectives:**

- To be able to identify ethical standards for counselors, describe client rights and understand legal requirements for counselors.
- To understand licensure and regulatory practice.
- To gain a knowledge of standards of the code of ethics of The American Counseling Association and the American Mental Health Counseling Association.
- To identify specific issues relevant to substance abuse and addiction.
- To understand the worth, dignity and diversity of cultural backgrounds of individuals.

#### **Methods of Evaluation:**

Students will be evaluated on contributions to class discussions, written and oral work and attendance.

Students missing more than two classes will not receive credit for the course. Please submit an excused absence form in advance to the instructor.

## **Course Requirements:**

**Readings:** Complete the assigned readings and be prepared to discuss them critically in class. For each class a (typewritten) concise commentary and analysis of that week's readings is to be submitted.

**Logs:** A log is required for each class. Logs may contain any communication a student wishes to make to the instructor. An ideal log contains comments about class assignments, the class process and the student's feelings. Please submit logs on a 5x8 index card, typed or written legibly.

**Presentations:** Each student will make a mini oral presentation on a topic of their choice corresponding to the class topics. More details to be discussed further in class.
